Directions to trial site:

From I-55 (north or south) exit at Highway 302 (Goodman Rd) East. Go to Hacks Cross Rd and turn right. Go approximately one mile to Whispering Pines Drive and turn left. Show site is at 11500 Whispering Pines Drive (tenth house on the left hand side of street).

From I-40 (east or west), exit on I-240 south. Exit on Nonconnah Parkway (Hwy 385) south. Exit on Hacks Cross Rd South. Go to Whispering Pines Dr and turn left. Show site is at 11500 Whispering Pines Dr. (tenth house on left hand side of street).

No concessions will be available at trial site. There are several restaurants and fast food places nearby.

Entries open May 26, 2010, entries must not be postmarked prior to May 26th.
