**Directions to show site:** BRLEJ Farm-11511 Mattioda Road, Groveland, FL. From North/West: I-75 to FL Turnpike, to Exit 289, take US 27 South –Tavares/ Clermont, take SR-19 South ramp toward Groveland. Merge onto FL 19, go 6.4 miles into Groveland, 19 becomes becomes Lake Ave, this will become Empire Church stay on for about about 2.5 miled. Turn Left onto Mattioda Rd and follow signs to Show Site. From North/East: I-95 to I-4 to Orlando, take Exit 92 right, SR-436 Semoran Blvd. 6.9 miles, merge onto US-441 1.9 miles to SR-429, 10.1 miles Exit 22, FL Turnpike 4.5 miles, turn left (west) onto SR-50 (W Colonial Dr) 13.3 miles, Turn left onto SR-33, turn right onto E Anderson Rd, turn left on Empire Church Rd, go 1.7 miles, turn left onto Mattioda Rd, follow signs to show. From South: FL Turnpike North to Exit 272 SR-50 Winter Garden/Clermont, turn left (west) onto SR-50 (W Colonial Dr) 13.3 miles, Turn left onto SR-33, turn right onto E Anderson Road, turn left on Empire Church Rd, go 1.7 miles, turn left onto Mattioda Rd Follow signs to show.

are reached (12 duck runs and 20 sheep runs each trial Friday and Sunday Cattle 8 only). Each handler is responsible for his dog and must keep it controlled at all times. Dogs will be brought to and from the ring on leash. Handlers will be responsible for any damage to the livestock caused by their dogs, fair market value will apply. Run order will be determined prior to trial. Females in heat run last. Stock Dog Awards: 1<sup>st</sup> through 4<sup>th</sup> place, qualifying ribbons will be awarded for qualifying scores, HIT Sheep, HIT Ducks, HIT Cattle (Friday/Sunday), HIT Aussie and HIT Junior each trial. Entries must be signed on the reverse. Stock classes are open to dogs of any registry. Non-ASCA registered dogs must have an ASCA Tracking Number to compete.

**Attention Exhibitors:** The shows will be judged and run under the show rules for the Australian Shepherd club of America. Dogs must be ready for judging. No refunds will be given for dogs absent, disqualified, excused or barred from exhibiting by the show committee. Refunds will be given up to the close of the pre-entry deadline. Substitutions may be made with dogs owned by the same exhibitor. No entry which specifies any condition as to its acceptance will be accepted. No electrical or mechanical training devices are allowed on the show grounds. Entries must be made on official ASCA entry forms. Copies of entry will be accepted only if they are completed with the agreement on the reverse side. The show giving club, show chairman, their agents, officers, and committee assume no responsibility for loss, damages, or injury sustained by exhibitors, handlers, or to any of their dogs or personal property and further assume no responsibility for injury to children.
