AUGUST 2, 3, 4, AND 5TH, 2012 (Thursday thru Sunday)

Three Pine Ranch, Estancia, NM (one hour east of Albuquerque, one hour southeast of Santa Fe)

DIRECTIONS TO SITE: Site is open 8/1, Wednesday noon, to 8/6, Monday noon.

► **LEAVING ALBUQUERQUE/HEADING EAST:**

From I-40 east of Albuquerque, get off in Tijeras and take 337. Head south, staying on 337 (about 37 miles) until it deadends into Highway 55. Turn left heading east. Watch for milemarker 89 on your righthand side (that is county road AO27/**Riley Road**). Turn right; it's a blacktop road. Go down until you come to the first dirt road that turns left; there is a cluster of mailboxes at the corner (Shope is not among them); this is AO32/Langley Road. Turn left onto AO-32, Langley Road. The ranch is the first entrance on your lefthand side.

► **COMING FROM SOCORRO TOWARDS BELEN/HEADING NORTH:**

From I-25 south of Albuquerque, take highway 60 to Mountainair. Turn left from Mountainair onto highway 55. Watch for highway 542 which forks to the right and turn onto that highway. Eventually that road heads east. Next turn left onto AO27/**Riley Road** (black top road – you've passed Riley if you see Solomon Rd!) and follow Riley down to county road AO32 (Langley on your right). Langley is a dirt road; watch for the cluster of mailboxes on the corner). The ranch is the first entrance you'll come to when driving down Langley.

► **COMING FROM RATON/LAS VEGAS/GLORIETA/HEADING SOUTH:**

From I-25 north of Santa Fe (bypassing Santa Fe & Albuquerque both) - take highway 285 just outside of Glorieta. Then take the right fork onto highway 41. Follow highway 41 into Moriarty and then on into Estancia. At Estancia, go through the town to the end at which time you'll come to highway 55, turn right and follow it until you see AO30 (Ranchhouse Road)(it's before mile marker 89). Watch on your lefthand side for AO30; turn left onto AO30; it'll deadend into AO32 (no sign for the road). Turn right and the ranch is the first entrance you'll come to on your righthand side. (If you pass AO30, Ranchhouse Road, watch for milemarker 89 and Riley Road next, black top road – turn left on it and then left again on Langley).

► **COMING FROM CLOVIS ON HIGHWAY 60**

Watch for the exit for highway 41 that goes into Estancia. Turn right onto highway 41. Just before you get to Estancia, you'll come to highway 55. Turn left onto highway 55. Follow it until you see AO30 (Ranchhouse Road)(it's before mile marker 89). Watch on your lefthand side for AO30; turn left onto AO30; it'll deadend into AO32 (no sign for the road). Turn right and the ranch is the first entrance you'll come to on your righthand side. If you pass AO30/Ranchhouse Road, you'll come to milemarker 89/Riley road, AO27 – follow instructions above for that road.

If lost, call 505/384-2547 (landline) or 505/328-5092 (cell phone) – No practices runs available on livestock – Tennis Court is off limits except at show/trial times

OBEDIENCE & RALLY are open to all breeds. STOCK TRIAL is open to ASCA approved herding breeds. Rulebooks and entry forms are available at the link below. Owners/handlers of non-Aussies may complete the application for a tracking number by picking up an application at the Registration table or downloading the form to obtain a tracking number at: <http://www.asca.org/Forms+and+Rule+Books> Mark pending in registration number on entry blank if tracking number is applied for but not yet received.

STOCK DOG TRIAL INFORMATION

STOCK DOG JUDGES: Tony Padgett, GA and David Clayton, FL (each may judge up to 50 runs per day dependent upon stock availability)

ARENA INFO: (Course A/back arena - 180' X 390' Take-Pen/Re-Pen 20' x 20') (Course B - Duck Arena: 90 x 100) Course B/front arena (160' x 280' Re-pen 16 x 16)

OFFERING: For exhibition only, working junior handler, open junior, novice, started, open & advanced

RUN ORDER: Drawn the night before; day of entries run in order of receipt. Bitches in heat run last in each class of stock.

ENTRY INFORMATION: PRE-Entries open 6/15/2012 (Fri) and close 7/25/2012 (Wed). Entries are accepted by postmark date from 6/15 to 6/24; thereafter by receipt date. No postmarks prior to 6/15/2012! Day-of fees are applicable from 7/26/2012 thru registration for each trial. Check the Lobo website <http://www.loboasanm.com> to see who has made it into the trial and who is on a waiting list. No pre-entry hand deliveries will be accepted during the ten-day postmark acceptance period. Waive signature if using priority or express mail! Entries will not be accepted via email or facsimile. All entries must be on an ASCA up-to-date entry blank. Entry blanks may be downloaded at: <http://www.asca.org/Forms+and+Rule+Books> or one can be mailed to you via USPS. A copy of your dog's registration paper would be greatly appreciated. Checks will be deposited weekly. Any check resulting in insufficient funds will result in a penalty fee of \$25 per check. Checks must be made good within five days of notification by the Club and the penalty fee paid or entry will be voided, any legs or points earned voided, awards won must be returned, and the checkwriter will be placed on a cash-only basis thereafter.

REGISTRATION: 7:15 to 7:45 a.m. (check in at the Hospitality Area near the main house)

HANDLERS MEETING: 8:15 a.m. (meet at the Hospitality Tent by the main house)

STOCK: (*d=ducks; c=cattle; s=sheep – 50 runs per day per judge*) **Thurs:**dc-Clayton; s-Padgett; **Fri:** dc-Padgett; s-Clayton **Sat:** dc-Clayton;s-Padgett; **Sun:** dc-Padgett; s-Clayton – *Based upon stock availability*

8:30 A.M. – Duck Trial begins (ALL GENERATORS MUST BE OFF DURING THIS TRIAL) – Cattle Trial will immediately follow the conclusion of the Duck Trial (Ducks are always Course B)

8:30 A.M. – Sheep Trial begins *A=A course B=B course*(**Thur:** cattle/A; sheep B; **Fri:** Cattle/B; Sheep/A; **Sat:** cattle/A; sheep/B; **Sun:** cattle/B; sheep/A – *Don't enter pasture area by arena if someone is trialing their dog.*

EXHIBITORS: Stock takes precedence over rally, obedience and conformation with the single exception of group exercises in obedience. If you have arena or ring conflicts, let your judges know. Be courteous to those already in line to run by asking permission to cut in front of them.

AWARDS: These will be at handed out at the Hospitality Tent area near the main house. For those absent from the awards ceremonies, check the cardboard box at the hospitality area for your score sheets. If you were to get a ribbon, it'll be in that box and your placement noted on your score sheets. Awards are given out approximately one half our after the trial has concluded.

DAILY ROSETTES TO: High Combined Aussie, High Combined Other Breed, Most Promising Started Aussie, Most Promising Started Other Breed, High in Trial Sheep, High in Trial Ducks, High in Trial Cattle, HC Working Junior – STRIP RIBBONS 1ST THRU 4TH

DAILY PRIZE WILL BE GIVEN TO: High Combined Overall, Most Promising Started Overall, High in Trial Overall

CLASSIC STOCKDOG TRIAL CLUSTER PRIZES: Prize to High Combined Junior. Sterling Silver Belt Buckles to those named below. Mark on your entry if your dog is competing for one of the buckle awards named below:

High Combined WTCH Aussie and High Combined WTCH Other Breed – Winners will be the dog with the highest combined scores from the four days of trialing from the open and advanced classes

High Combined Non-WTCH – Dog must NOT have earned its WTCH title prior to the pre-entry opening date for this Classic. Winner will be the dog with the highest combined scores from the four days of trialing from the open and advanced classes.

Most Promising Started Aussie and Most Promising Started Other Breed – Winners will be the dog with the highest combined scores from the four days of trialing from the started classes.

LIVESTOCK (if your dog injures or kills): Cattle are feeders (*market price replacement), Sheep are Mixed Hair (\$200 replacement), Ducks are Indian Runners or Magpies (*\$25 replacement), *Or you pay the applicable vet bill or well care deemed necessary

ENTRY FEES: Pre Entry Fees are \$45 cattle; \$40 sheep; \$35 ducks (add \$5 after pre-entries close). If entering all four trials all stock for the same dog, entry fee is \$425. Substitutions are: \$5.00 PER DOG substituted. Moveups: Allowed

A copy of your dog's registration would be greatly appreciated.

No plans for an overflow judge at this time so send in your entries timely.

If applicable, a random draw will be conducted to determine order of acceptance into the trial and a waiting list made available by order of draw or receipt. Each dog will compete for entry separately in the draw order.

No entry shall be made and no entry shall be accepted which specifies any condition as to its acceptance.

CONFORMATION, OBEDIENCE & RALLY SCHEDULE OF EVENTS

PLEASE READ: EXHIBITORS & JUDGES, stock runs take precedence over all other disciplines. Exhibitors, let your judges know if you have a conflict. Rally cannot be ran out-of-class order – be on the line timely for your turn. Conformation Judges, you may run classes out of order provided all dogs are present for the class you call. Exhibitors, please be as timely as you possibly can so we use our daylight wisely. Good luck to all of you! **TWO REGISTRATION TIMES PER DAY: *7:20 a.m to 7:50 a.m. and **2:00 to 2:30 p.m. GENERATORS OFF during duck trial hours!**

OBEDIENCE: Classes for utility & open levels are A, B, and V (veterans) – Veterans class doesn't qualify for HIT award but is a regular title earning class – veterans are age 7 and may up and jump lower heights

ENTRY FEES: Pre-entries open 6/15/12 and close 7/25/12. Day of fees are applicable 7/26/2012 thru registration for each event. No entries postmarked or handdelivered prior to 6/15/12.

Offering Regular Classes: Pre-entry \$15.00 (same dog/same class 3 times or more – reduce class fee to \$10/class entered) Day-of fee: add \$5.00 per day per dog/not per class entered (Altered & Intact 6 months of age and older – must have ASCA Registration Number) (Novice, Open, & Utility obedience classes plus Masters, Excellent, Advanced & Novice rally classes – must have ASCA Registration Number or Tracking Number) Age computed as of day of show or trial entered.

Offering Non Regular Classes: \$10 (same dog/same class 3 times or more – reduce class fee to \$8/class) Day-of fee: add \$5.00 per day per dog/not per class entered (Puppies – mark “pending” if registration number is applied for. Grad novice or sub novice obedience must have ASCA Registration Number or Tracking Number) Age computed as of day of show or trial entered.

Offering Juniors: \$1.00 per class for junior handling in conformation. Juniors may handle any breed. All other entry prices are applicable for regular classes of stock, conformation, rally & obedience. Day-of fee: add \$5.00 per day per dog/not per class entered.

CONF/RALLY/OBED ENTRY INFORMATION: Waive signature if using priority or express mail. Entries will not be accepted via email or facsimile. All entries must be on an ASCA up-to-date entry blank. Entry blanks may be downloaded at: <http://www.asca.org/Forms+and+Rule+Books> or one can be mailed to you via USPS. Remember, other breeds must have a tracking number if entering rally or obedience. You may apply for a tracking number at the link above or complete the form to apply for one at the registration table. A copy of your dog’s registration paper would be greatly appreciated. Entries must be accompanied with the RECAP SHEET included in this flyer. Checks will be deposited weekly. Any check resulting in insufficient funds will result in a penalty fee of \$25 per check. Checks must be made good within five days of notification by the Club and the penalty fee paid or entry will be voided, any legs or points earned voided, any awards must be returned, and the checkwriter will be placed on a cash-only basis thereafter.

MOST VERSATILE, CONFORMATION, & RALLY AWARDS:

MOST VERSATILE ANY BREED AWARD: If you are entering, please designate this on your entry blank. Entry fee is \$5.00 and covers your MVA conformation evaluation on Sunday morning. RULES: Dog must have a qualifying stock run, and the highest score earned will be used as the base score. Your dog will earn an extra 5 points for each additional qualifying stock run. Your dog must have a qualifying score from Rally and/or Obedience. The highest score earned will be the performance base score. Your dog will earn an extra 5 points for each additional qualifying score from Rally and Obedience. Your dog must have an MVA Evaluation score. Top cumulative scoring dog will take the Most Versatile Any Breed Prize. Scores are computed over the four days of trials/shows.

OBEDIENCE & RALLY: Rosettes will be given to: HIT Rally, HIT Obedience, HC obedience (when utility is offered) for each trial. Prize will be given for the Cluster Rally HC and Cluster Obedience HC (cumulative qualifying scores all four days) and High Junior for the Cluster.

CONFORMATION: Rosettes will be given to: Intact and Altered BOB, WD, WB, RWD, RWB plus BOBp, BOSp, BJH and RBHJ for each conformation show. Prize will be given for the Cluster Conformation winners: Intact dog and Altered dog who have beaten the most dogs at the Cluster; Intact bitch and Altered bitch who have

beaten the most dogs at the Cluster; Puppy who has beaten the most puppies at the Cluster; and Junior handler who has beaten the most juniors at the Cluster.

ALL EXHIBITORS AND VISITORS, PLEASE NOTE:

REFUNDS: Entry fees will not be returned if the dog's entry is pulled or withdrawn. Entry fees will not be returned if the show cannot be opened or be completed due to riots, civil disturbances, acts of God, public emergencies or other events beyond the control of Lobo ASA. Entry fees will not be refunded if the dog is absent, disqualified, excused or barred from competition by the Show Committee, ASCA, the Host, show veterinarian, Course Director, Livestock provider, or stockdog judge.

SUBSTITUTIONS ARE ALLOWED BY HANDLER OR OWNER. \$5.00 fee per day per dog substituted/not per class entered. You will be required to complete a substitution form – it's attached to this Flyer and will also be available at the Registration tables.

STOCK RUNS. If the trial fills and your run is sold, you will be refunded within TEN (10) days once the Classic is over.

ASCA RULES ARE APPLICABLE and are strictly enforced.

HOLD HARMLESS: The Show Secretary, Show/Trial Committee, Members of LASA, and the owners of the host facility, Legends Three Pine Ranch & Australian Shepherds L.L.C., assume no responsibility for any loss, damage or injury sustained by any exhibitor, handler, dog, property, child or spectator. This show & trial are being held on private property. You understand by your attendance and/or entry and entry that the Show/Trial Committee and Hosts have the right to refuse or excuse any entry or spectator for good cause. Good cause would be violation of the private property owners' rights or violation of the ASCA show rules.

TRIAL SITE: Legends Three Pine Ranch, 671 Langley Road, Estancia, NM 87016-8032, around 6600' altitude - tie tarps securely (t-posts highly recommended); no dumping on site; dress in layers (bring coats); use sunscreen; terrain can be uneven - dryland pastures; high desert. Obedience, Rally & Conformation will be held on a tennis court. The court is sprayed down with water if the surface gets hot. The water does not make the court slick.

CAMPING ON SITE: \$15/night for electric (no sewer hookups - handicap get priority); \$10/night for dry camping - water available to fill tanks - portapotties on site - **MAKE CHECK PAYABLE TO "Anne Shope" for any camping fees and forward your reservation and check with your entries fees.** Note: Electric is limited to availability. If you are unable to attend, you will be refunded your camping fees. No refund for campers who arrive late or leave early. Do not dump bedding on the ranch if utilizing portapens.

VENDOR: We do have a food vendor for the Classic. Please support our vendor. Anyone wishing to sell products other than food may set up a tent and do so provided they donate an item equivalent in worth of no less than \$50 to the Lobo Raffle.

RAFFLE: Our raffle benefits ASHGI, Inc. (Australian Shepherd Health & Genetics Institute, Inc.). Raffle drawing will be Sunday following the day's events. You need not be present to win but please make arrangements for

someone to pick up any raffle wins – Lobo will not be mailing these out. Raffle tickets are available at the hospitality area and raffle items are listed or exhibited.

AWARD SPONSORSHIPS: \$100 sponsors a belt buckle. \$25 sponsors all other awards. Co-sponsorships always welcome. Please let us know how you would like your sponsorship listed.

VOLUNTEERS, you will receive a free lunch, free snacks and drinks, for each day you volunteer to steward, time keep, or stock handle. Lobo thanks you so much for volunteering your time. If you'd like to lockdown how you'd like to volunteer, please let the Entry Clerk, Course Director, or Show/Trial Secretary know. We will do our best to get you your first choice. Stewards needed in obedience, conformation or rally, timers in stock and in rally, stock handlers for sheep, cattle & ducks - VOLUNTEERS are the backbone of our trials & shows – THANK YOU!

- * Please keep all dogs on lead when not competing. Pick up after your dog.
- * Keep children and dogs back from the arenas; keep children & dogs quiet when a team is competing.
- * Stay behind all caution tape. We have taped areas to keep distractions to a minimum at the duck arena and at the tennis court.
- * This trial site can have snakes (rattlers included). Call for the hosts if you encounter a snake.
- * There is no vet on site and no vet on call. A listing of vets is readily available on the bulletin board in the garage. Vets can be one-half to one hour away. Doctors are one-half to one hour away. Hospitals are one hour away. First aid is available at your discretion; you agree to hold harmless any individual aiding or giving first aid.
- * **NO DOGS ON THE TENNIS COURT** unless competing. You may exercise dogs in the pasture area; please pick up after your dogs. **PICK UP** after your camping site or set-up site.
- * No dogs up at the main house or on the lawn areas. You may take your dog with you to the hospitality area.
- * No photographer on site. Win shots, however, may be coordinated with Stephanie Shope-McDaniel if you do not have a camera or with other photographers on site. Note that different photographers will have differing prices. **Lobo ASA appreciates a complimentary copy of your win photo.**
- * Good sportsmanship is a must. Any grievances should be directed immediately and quietly to the Show Committee Chair: Stephanie Shope-McDaniel. Stephanie will timely contact the applicable person or persons to address any grievance.
- * No alcoholic beverages during competition hours. Please wait until all trials/shows are completed.
