**Entries with missing or incomplete information will be returned and does not constitute an entry**

- All Aussies over six (6) months of age may be asked to show proof of ASCA registration. Be prepared to present registration papers on all dogs six (6) months of age or older as of the date of the show.
- All dogs may be asked to show proof of rabies vaccination. In that event, a certificate from a licensed veterinarian is required.
- Any dog that displays viciousness toward people or animals at any time on the show premises will be ejected from the show site for the entire show weekend with no refund of entries.
- Physical abuse of any animal will not be tolerated. Any person on the show site reported to have physically abused an animal will be ejected from the show site for the entire show weekend with no refund of entries, and will be subject to disciplinary action per ASCA rules.
- No puppies less than 8 weeks of age are allowed on the show site. Absolutely no puppy sales allowed on the show grounds.
- RRVASC, its Board of Directors, ASCA, its Board of Directors, and the property owner assume no responsibility for any loss, damage or injury sustained by exhibitors, handlers or to any of their dogs, personal property and/or children.
- Training on the grounds is prohibited.
- Dogs must be on leash at all times. Do not exercise dogs in stock or agility areas, including stock holding areas.
- Do not leave unattended dogs on grooming tables.

This property is the **home** of a club member who has graciously offered it for our use. Please be mindful, respectful, and comply with these rules:

- Rock River Valley practices the *PUP Policy* (Pick it Up People). Anyone caught not cleaning up after their dog is subject to ejection from the show site, no refund of entries. Please keep your grooming/crating area neat, including excess hair. The wildlife has enough nesting materials, and the resident sheep do not wish to graze on hair.
- Please exercise dogs in appropriate areas, i.e. avoid landscaping, car tires, garbage cans, stock pens, etc.
- Smokers—please pick up cigarette butts and other smoking remnants.

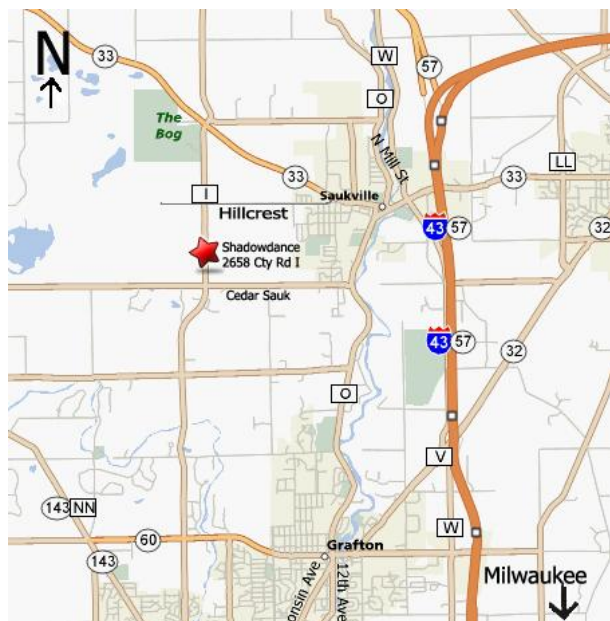
**FOOD WILL BE AVAILABLE ON SITE BENEFITING LOCAL GIRL SCOUT TROOP**

**DIRECTIONS:** Shadowdance is located on the east side of County Road I in the town of Saukville, between Hwy 60 (to the south) and Hwy 33 (to the North). **2658 County Road I, Saukville, WI.**

**From the southwest:** Hwy 60 east towards Grafton. North on Hwy I 3.25 miles.

**From the northwest:** Hwy 33 east towards Saukville. South on Hwy I approximately 1.5 miles.

**From Hwy 43 either direction:** Exit Hwy 33/Saukville west. Hwy 33 through town approximately 1 mile following Hwy 33 to the right. Hillcrest Road is angled off Hwy 33 on the left, ½ block after the last set of lights (Citgo station on that corner). Left on Hillcrest to Hwy I. Left on I approximately ½ mile.
