Motion by Warren, Liaison for the Stock Dog Committee

I move to accept the following SDC recommendation.

Comment: Currently a 10 foot gate is allowed. To go into effect 30 days after it appears in the Aussie Times (February 15) to be placed in the January 2002 Rule Book.

Change CH. 3 Sec. 11.2c Panels to read:

c. Panels - Duck arena panels will be four (4) feet long and at least two (2) feet high. Cattle and sheep arena panels will be eight (8) to twelve (12) feet in length and will be at least four (4) feet high. Note: the free-standing pen panels for cattle and sheep must be a minimum of twelve (12) feet and a maximum of sixteen (16) feet with a gate of no less than twelve (12) feet.

Comments: It is felt that to be consistent with the size of the free-standing pen requiring a twelve foot gate would be more consistent than what the rule currently says. It will also give the animals a larger minimum opening into the pen.

SECTION 4 - DOGS THAT MAY NOT COMPETE

An ASCA Stockdog Judge cannot compete nor can any dog owned or co-owned by that Judge compete at the same sanctioned trial he/she is officiating. The Judge shall not judge any dog which he/she or member of his/her immediate household or immediate family owns or is currently handling. The Judge's immediate family include: spouse, father, mother, son, daughter, brother, sister, or any person residing with that individual. Immediate family members of an officiating Judge may show under another officiating Judge at the same trial.

Comments: It has been asked a few times from the SDC to clarify this rule so we made this motion hoping to delete any misunderstandings.

CHAPTER 7

JUDGES

SECTION 1- JUDGE'S DUTIES

Authorization - The ASCA Approved Stockdog Judge is authorized in his capacity as the ASCA representative to pass judgment on contestants in the trial and to act as an official Inspector/Judge for the ranch dog applying for certification. This authorization is granted by ASCA and can be revoked at any time by ASCAs Board of Directors.

ASCAs Stockdog Committee is the advisory body of ASCAs Board of Directors and is empowered to review and pass on the qualifications of all applicants wishing to be appointed a Stockdog Judge, to investigate all complaints and review competence and compliance with all ASCAs rules and procedures relating to stockdog judges.

Fraternization - Judges should avoid improper fraternization with the contestants and spectators during a trial.

Conduct - All ASCA Stockdog Judges will be expected to conduct themselves in a manner consistent with the following Code of Ethics:

Judging is a privilege, not a right. The ASCA Stockdog Judges conduct must always be impartial, dignified and respectful of the welfare of the dog, stock and the handler. A Judges actions and professional compoment must be above reproach.

Judges shall be professional in demeanor and shall refrain from making coaching comments to the handler during the contestants the safety of the stock, dog and handler shall be the Judges foremost concern in reviewing the trial conditions and in judging a working trial.

Judges shall score a trial based solely on the dog and handlers performance as a team as described in the ASCA Stockdog Rules and Regulations, and in no case shall be based (nor any consideration be given) on the identity or reputation of the handler, owner, the breeder, or the dogs lineage.

Judges shall remember that trials are staffed largely or entirely with unpaid volunteers, and shall treat stock handlers, timers, helpers, exhibitors and spectators with due courtesy and consideration.

Any Judge found abusing the privileges of judging for ASCA or violating this Code of Ethics may have his/her judging privileges revoked or suspended by ASCA.

Seminars - All ASCA approved Stockdog Judges are encouraged to attend Judge's seminars. A set of general seminar minutes must be turned in to the ASCA Business Office by the SDC representative within fifteen (15) days of the seminar, listing those in attendance and points of discussion, decisions or suggestions.

Membership - Judges are encouraged to become ASCA members.

All ASCA Stockdog Judges will be required to take an open book test administered by the ASCA Stockdog Committee every two (2) years. All questions must be answered correctly. The test may be retaken until all questions are answered correctly. If the test is not passed and returned by April 30th of that year, judging privileges and responsibilities will be suspended until the test is returned and passed. Judges test will be sent out January 1st (every two years) along with an updated rule book and must be received back by April 30th of that year.

SECTION 2 - PROTESTS

Any person wishing to lodge a protest or complaint against a Judge shall do so in accordance with the ASCA Dispute Rules.

SECTION 3 - DISCIPLINE

A Judge may be temporarily denied judging privileges for a period of sixty (60) days by the Stock Dog Committee while it investigates any allegation of a serious infraction or violations of the Judges Code of Ethics or ASCAs Rules and Procedures. Any Judge may be suspended from judging assignments by the ASCA Board of Directors upon the recommendation of the Stock Dog Committee, provided the Stock Dog Committee has proposed a course of remediation to resolve the rule infraction. If a formal complaint is filed against a Judge concerning a trial it shall be investigated by the Stock Dog Committee and if the complaint is found to be valid, the Judge may be suspended or have his/her judging privileges revoked. The ASCA Dispute Rules must be used in all complaints against Judges.

CHAPTER 8

APPRENTICE STOCKDOG JUDGE PROGRAM

SECTION 1- MINIMUM ELIGIBILITY REQUIREMENTS

Membership - The applicant for Apprentice Judge must be a member in good standing of ASCA for a minimum of five (5) years and have trialed and owned Australian Shepherds for a minimum of five (5) years at ASCA working trials.

Interest - The applicant for Apprentice Judge must be the owner of Australian Shepherd dogs and be interested in the betterment of the breed.

Experience - The applicant for Apprentice Judge shall demonstrate a reasonable amount of livestock experience in addition the applicant must have owned and handled two (2) Australian Shepherds to their WTCH in entirety. (Applicant must have owned and handled each Australian Shepherd from started through advanced in ducks, sheep, and cattle).

Training - The applicant must have worked and trained Australian Shepherds for use on livestock.

References - Three references are required from people who have personal knowledge of the applicants qualifications as pertaining to livestock experience, experience working dogs with livestock and the applicants personal character. References must come from individuals in the livestock industry. (Examples: Individual that raises livestock, a veterinarian, an ASCA Stockdog Judge) Only one (1) ASCA Stockdog Judge maybe used as a reference. If an ASCA Stockdog Judge is used as a reference, the Apprentice may not apprentice under that Judge.

The applicant must have been a Course Director at least one (1) ASCA Stockdog Trial with sheep and cattle.

SECTION 2 - APPLICATIONS

ASCA Apprentice Judge applications are available from the ASCA Business Office.

SECTION 3 - ACCEPTANCE

Judging at an ASCA sponsored event is an honor and a privilege, not a right. Judging applicants must satisfy ASCA's stated minimum eligibility requirements for Judges, but satisfying this set of minimum requirements grants the applicant the right to be considered for the position of Stockdog Judge but does not entitle an applicant to become or remain an ASCA Judge. An applicant may be turned down due to, but not limited to: documented poor sportsmanship; abuse of dogs and/or livestock during ASCA trials. In addition to satisfying other stated qualifications to serve, an applicant, similarly to qualified Stockdog Judges, must consistently display the highest level of ethical conduct, impartial demeanor, professional compartment and dedication to the Judges Code of Ethics and to upholding ASCA's codes, rules, decisions, procedures and the Statement of Purpose in ASCA's bylaws. Failure to perform on this level may result in denial or revocation of judging privileges by the ASCA Board or appropriate committee without regard to any other qualification or prior service.

The acceptance of an Apprentice Judge applicant is made by the Stock Dog Committee (SDC), after the ASCA Business Office forwards the application to the ASCA Stock Dog Committee. All Applicants for Apprentice Stockdog Judges will have their names published in the Aussie Times for comments before

being voted on by the SDC. Once published, there will be 45 days for comments to be received by the Stockdog Committee Chair before the SDC will vote. The applicant will be notified of acceptance or denial as an Apprentice Judge by the ASCA Business Office after the SDC vote. If the applicant is turned down, the reason for denial will be forwarded to the applicant by the ASCA Business Office. The applicant may reapply after waiting a minimum of two (2) years.

SECTION 4 - APPRENTICESHIP

Start of Apprenticeship

All apprentices must agree in writing to abide by all ASCA's codes, rules, decisions, procedures, the Statement of Purpose in ASCA's bylaws and the Judges Code of Ethics after acceptance prior to apprenticing.

The apprentice must take an Open Book test administered by the ASCA Stockdog Committee based on the ASCA Stockdog rules and procedures. All questions must be answered correctly. The test may be retaken. When the test questions are sent out, a current copy of the Stockdog Rules and Procedures will also be sent. This test must be passed before starting the Apprentice Judging.

Trial Application - An Apprentice Judge wishing to work sanctioned trials must make an application to the ASCA Business Office no less than thirty (30) days prior to the date of the trial. Only those trials which are sanctioned will be accepted for meeting the required number of trials. The application shall state the host club, date, and name of the ASCA Judge whom they will be working with.

Trials - The first trial must be worked within twelve (12) months of receiving notification from the ASCA Business Office of acceptance. The third trial should be completed within twenty-four (24) months of notification unless an extension has been approved by the ASCA Stockdog Committee.

Number of Apprentices at a Trial - No more than one (1) Apprentice Judge may work under any one (1) Judge at a trial. Apprentice Judge assignments will be made on a first-come, first-served basis.

Different Judge - The Apprentice Judge's first two trials will be worked under different Judges. The Apprentice Judge must score in consultation with the ASCA Approved Judge(s) during the first two trials (cattle and sheep) and all duck trials. Apprentice Judges may not work under an ASCA approved Provisional Judge. The third trial on sheep and cattle will be scored independently.

Number of Trials - The Apprentice Judge will work a minimum of three (3) ASCA sanctioned trials on both cattle and sheep and one (1) on ducks. A minimum of sixty (60) runs each must be judged on sheep and cattle, 30 on ducks. The Apprentice Judge will work one (1) trial outside of their region in which they reside with a minimum of twenty (20) runs each of cattle and sheep.

May Not Compete - The Apprentice Judge may not act as a contestant on any day he serves his apprenticeship. His/Her immediate household or immediate family and his/her dogs may compete, but not be scored by the Apprentice Judge.

Notification - The ASCA Business Office will notify the Judge and host club when an Apprentice Judge has been scheduled to judge.

Scoring Check - The Apprentice Judge's scores will be compared to that of the ASCA Judge(s) during or directly after the trial. The Judge's comments will be discussed at that time. The score comparison and comments will be signed by the Judge and forwarded to the ASCA Business Office.

Scoring Consistency - The Apprentice Judge will complete the apprentice score sheet in its entirety. The scores will be checked for consistency in all trials against those of the Judge.

Lacking Consistency - If the work of the third cattle and sheep trial of the Apprentice Judge, which must be done without assistance from the Judge, appears to be lacking in consistency, the ASCA Stockdog Committee may request a number of additional trials on cattle and sheep be worked by the Apprentice Judge to acquire more judging experience. Should the scores of the requested additional trials prove unsatisfactory, the Apprentice Judge may be excused from the program by the SDC.

Certification as an Apprentice Judge - All score sheets, test scores, application information/verification, comments by Judges, and other interested parties (handlers, host clubs, and others who observed the Apprentice) will be forwarded to the ASCA Stockdog Committee. The ASCA Stockdog Committee will vote whether to recommend appointment as a Provisional Stockdog Judge, or to dismiss the Apprentice Judge from the program. The Stock Dog Committee shall submit the result of the vote and the supporting reasons and documentation along with the committee members comments to the ASCA Business Office. The ASCA Business Office will provide the ASCA Board of Directors with the Stockdog Committees recommendation, supporting reasons, documentation, along with the committee members comments and the apprentice's resume. The ASCA Board of Directors will vote on the SDCs recommendation within ninety (90) days of the date it receives the recommendations of the Stockdog Committee.

SECTION 5 - PROVISIONAL STOCKDOG JUDGE

Upon appointment by the ASCA Board of Directors of an Apprentice Judge to the position of Provisional Stockdog Judge, the Provisional Stockdog Judge shall serve a probationary period of two (2) years, which must include judging at least six (6) stock trials consisting of at least two trial days of sheep, cattle or ducks. After the completion of the probationary period, the conduct of the Judge shall be reviewed by the ASCA Stockdog Committee. The ASCA Stockdog Committee will vote whether to recommend appointment as a full Stockdog Judge, or to dismiss the Provisional Stockdog Judge from the program.

The Stock Dog Committee shall submit the result of the vote and the supporting reasons and documentation along with the committee members comments to the ASCA Business Office. The ASCA Business Office will provide the ASCA Board of Directors with the Stockdog Committees recommendation, supporting reasons, documentation, along with the committee members comments

and the applicants resume. The ASCA Board of Directors will vote on the SDCs recommendation within ninety (90) days of the date it receives the recommendations of the Stockdog Committee.

93:17 STOCK DOG RULES -CH 3 Sec 1 The Sanctioned Trial

Motion by Warren, Liaison for the Stock Dog Committee

I move to accept the following SDC recommendation.

Comment: The change made here is allowing only two sanctioned trials per day. Some clubs were holding 3 a day. Effective date 30 days after it appears in the AT (February 15) to be placed in the Jan 2002 rule book.

Voting-SDC Meeting at Nationals September 18th 2001. A quorum of SDC members were present to conduct business and vote.

Motion by Sutherland seconded by Simmons

Change CH. 3 Sec. 1 THE SANCTIONED TRIAL to read:

The ASCA Sanctioned Trial will require the use of ASCA Stockdog Course A or B, its scoresheet and all other ASCA Stockdog Program criteria, including the sanctioning fee of \$15.00 per trial with a maximum of two (2) trials per day by a host club. The ASCA Sanctioned trial is the only trial in which Australian Shepherds, with ASCA individual registration numbers or LEP numbers, can apply their qualifying scores towards Certification. Other breeds and non-ASCA registered Australian Shepherds may apply their qualifying scores towards Certification at ASCA Sanctioned Trials as well. All ASCA Sanctioned Trials are required to use ASCA Approved Judges. Apprentice Judges may work for credit (see Chapter 8).

Comments: We were asked by the BOD to clarify this rule months ago and we have finally done so.
