### **ASCA Policy 4.2 Renewal Notification**

All affiliate clubs will be notified on, or before December 1st, of expiration of the deadline for renewal. Letters will be sent to the club President and Affiliate Representative, if they are not in the same household, giving them a final deadline of February 15th to renew. **If not received by deadline a \$100.00 late fee will be added (See Policy)** Additional officers of the club will receive a copy of the letter if the President and Affiliate Representative are in the same household. All applications for sanctioning for events between January 1st and February 15th will be held until renewal is received.

## **TO BE ELIGIBLE FOR RENEWAL**

- Each Affiliate Club **must** host at least one **(1) ASCA sanctioned event** and at least one **(1) educational project** yearly. Examples of educational projects are: Eye Clinic, Handling Clinic, Obedience, Working, or Agility Clinics.
- Each Affiliate Club **must** have at least ten **(10) individual members.**
