## GENERAL SHOW RULES

Having a problem at or during a show brings up the opportunity to look closer at our rules, and when doing so, we have discovered that a portion of a rule has been omitted from the new rule book. In 1990, in addition to CH. 3, SECTION 3.2 was passed by the Board:

***"ALL AFFILIATE CLUBS MUST SEND A SHOW FLYER TO THE SHOW SECRETARY'S OFFICE BEFORE THE DATE OF THEIR SCHEDULED EVENT."***

The rule is also in effect for all Stockdog events and is stated in those rules. It is very important that a show flyer be sent to the office so in case there is ever a discrepancy with that particular event, the office will have additional material to reference.

## C.E.R.F.

A motion was unanimously passed that ASCA obtain a membership to CERF. This membership will include: CERF semi-annual newsletter, CERF registration report for 1 breed, CERF research breakdown for 1 breed, CERF research summary report for all breeds, VMDB age/sex breakdown report for all breeds and a certificate of participation. Each one of these reports can be obtained singly for a fee; however, a yearly membership is more cost efficient and will give us all the reports. All this information will be passed on to the

membership via the Aussie Times.

## O.P. JUDGES APPLICATIONS

The Board has temporarily opened the O.P. Judges program using the Breeder Judge application and rules using other breeds where Aussies are referred to. The O.P.'s must be sponsored by an ASCA Affiliate Club and pass the Conformation Judge's test. Each application will be submitted to Jo Kimes, Ex. Secretary for Board approval or rejection. The Conformation Committee is in the process of rewriting the O.P. Judge's program.

## OBEDIENCE RULE

Page 24, Chapter 4, Section 1 Open A Class states: The Open A Class shall be for dogs that have won the CD title, but have not won the title CDX. OBEDIENCE JUDGES MAY NOT ENTER OR HANDLE DOGS IN THIS CLASS. This rule means that no matter what

class of obedience you are sanctioned to judge, if you are a Certified ASCA Obedience judge, you CANNOT enter in Open A. You must compete in Open B.

**OTCH PROGRAM**

Any dog who has met the requirement previous to January 1, 1993 will be awarded a OTCH providing the owner can produce the proper documentation to the ASCA Activities Coordinator for verification. Documentation that will be accepted is as follows:

1. Affiliate newsletter with dog's name, score and placing.
2. Aussie Times show results.
3. ASCA Yearbook show results.
4. ASCA functions only.
5. ASCA Business Office records.

Obedience Trial Champion certificates will be issued without numbers that define a rank, placement or order of completion. The only numbers used will be the date of issue and year earned. Because old dogs will be allowed certification of a OTCH, the office

has no way of knowing who was the first to complete all of the requirements and the fact that any dog who has attained this title should be the ultimate goal.
