This score sheet is an unofficial report for the sole purpose of helping the exhibitor with their training program. Following is the procedure for the use of the Unofficial Score Sheet and a copy of the score sheet itself.

From the Obedience Rules and Regulations, Ch2, Section 10, paragraph 2:

“It will be mandatory at all ASCA sanctioned Obedience Trials for the Obedience Trial or Show Committee to prepare an Australian Shepherd Club of America[®] Unofficial Score Sheet for regular obedience classes for each exhibitor that requests one the day of the trial. The Unofficial Score Sheet will be made available after the prizes are awarded only and must contain no more information than is shown in the Judges book or that is itemized on the score sheet itself.”

To be specific;

- a. Unofficial Score Sheets will be prepared for the Novice, Open and Utility classes. Sub-Novice and Graduate Novice are not mandatory.
- b. The exhibitor must request the Obedience Trial or Show Committee to prepare an Unofficial Score Sheet for them when they pick up their exhibitor numbers at the entry table.
- c. The Obedience Trial or Show Committee will make available to each exhibitor who requests one, an Unofficial Score Sheet filled out completely in all appropriate areas on the day of the trial as soon after the presentation of awards as is feasible. In all cases this must be completed the day of the trial.
