Requirements:

1. SANCTION FEE: \$25.00 PER DAY PER EVENT MAILED IN WITH REQUEST.
2. MUST BE POSTMARKED/HAND-CANCELLED NO LESS THAN 45 DAYS PRIOR TO TRIAL DATE.
3. LATE FEE: \$25 PER DAY UP TO 3 DAYS PAST THE 45 DAY DEADLINE, \$50 PER DAY THEREAFTER.
4. ANYTHING POSTMARKED 30 DAYS OR LESS PRIOR TO THE TRIAL WILL BE DENIED SANCTIONING.
5. SHOW FLYER THAT WILL BE SENT TO EXHIBITORS MUST BE INCLUDED WITH THE SANCTION REQUEST FORM.
