AGREEMENT

The person who signs this agreement represents that she/he is authorized to enter into this agreement on behalf of both Handler/Owner of the entered dog. In consideration of acceptance of this entry:

1. Handler/Owner, whether members or not of ASCA, will abide by the rules and regulations of the Australian Shepherd Club of America, and any other rules and regulations appearing in the premium list of the event.
2. Handler/Owner certify that the entered dog is not a hazard to persons, dogs or property and that the entered dog's rabies vaccination is current in accordance with the requirement of the state in which the dog resides.
3. Handler/Owner acknowledge all hazards represented by the event and the event premises, including, but not limited to, the condition of the fields, floors, stairways, halls, lighting, security measures or lack thereof, show grounds, parking areas and the presence of unfamiliar animals and people; Handler/Owner assume the risk of any harm arising from these.
4. Handler/owner release ASCA and will defend ASCA and hold it harmless from present and future loss, injury, damage, claims, demands and liabilities involving the entered dog, the event or event premises.
5. Additionally, Handler/Owner hereby recognizes the inherent danger of this event and assumes the sole responsibility for and agrees to indemnify, defend and save the aforementioned parties, including but not limited to Judges, tracklayers, or other volunteers, harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by the law upon and of the aforementioned parties for damage because of bodily injuries, including death at any time resulting there from, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such injuries, death or property damage may be caused, and where or not the same may have been caused by or may be alleged to have been caused by the negligence of the aforementioned parties or any of their agents or any persons.
