Classes offered Saturday: 1 round of Gamblers, 2 rounds of Regular, 2 rounds of Jumpers

Sunday: 2 rounds of Gamblers, 2 rounds of Regular

Sanctioned classes will be offered in the Standard, Veteran Dog and Junior Handler divisions in the Championship Program and Standard and Sr. Dog division in the ACE Program

Pre-entries will open on May 3rd and will close when the limit has been reached, postmarked no later than June 12th. Entries accepted after June 12th will be \$15 per class. If this trial does not fill, day of show entries will be taken on Saturday 7:30 – 7:45 a.m. Confirmations will be emailed by June 18th. Please make sure your E-mail address is legible. If Email is not legible or missing you will not receive a confirmation.

Miscellaneous rules and things you should know:

This trial will be held under the current rules and regulations of ASCA®. Exhibitors, through submission of entry, acknowledge that they are knowledgeable of the rules and regulations of ASCA® (Australian Shepherd Club of America) and agree to abide by all rules in effect at the time of this trial. A copy of ASCA's Agility Rulebook may be downloaded free from the ASCA® web site: www.asca.org.

ASCA requires a registration number for dogs in order to record and track scores for ASCA titles, an ASCA number is NOT required for participation. A Service Membership and QTracking number form is included in this premium and will be available at the trial or can be obtained on the ASCA website (<http://www.asca.org/Portals/o/trackapp.pdf>); if you want to have your dog's scores tracked for titles. **Entries will be accepted on the basis of those received on each day.** On any given day that the trial would fill with the entries received that day, the entries that were received on that date will be drawn at random. Confirmations, class run order and check-in information will be emailed to all entered. **If you urgently need to reach Sue during the days before the trial, leave a message on her cell phone (626-318-2494).**

WCASA will offer ribbons for 1st through 4th place in each class for each jump height division (**dogs jumping 24" optionally will be combined with the 20+ class**). Green ribbons will be offered to every dog obtaining a qualifying score. HIT awards will be offered in the Novice, Open and Elite levels in the Standard Division and to the HIT Overall Veterans and Jr. Handler in the Championship Program and an Overall ACE HIT award. The level of the regular classes the dog is entered in will determine the level of the award the dog is eligible for. Novice Q's = 5 points, Open Q's = 6 points, Elite Q's = 7 points. Faulted Q's will have half the point value listed above.

No entry shall be accepted from a dog or handler that has been disqualified from the ASCA Agility or ALL ASCA programs. All entrants must be in good standing with ASCA. All dogs must be on leash when not competing in the ring. **IT IS VERY IMPORTANT THAT DOGS ARE NOT ALLOWED TO RUN LOOSE/OFF LEASH.** Please clean up after yourself and your dog. No entry will be refunded if the trial cannot open or be completed by reason of riot, civil disobedience, fire and act of God, public emergency, and act of a public enemy, or any other cause beyond the control of the organizing committee. There will be no refunds for entries withdrawn after the closing date, or in the event a dog and/or handler are dismissed from competition, regardless of the reason for such dismissal. Refunds will be issued for bitches that come in season, if notification in writing is received before **June 23**. Checks not honored by the bank do not constitute a valid entry. **Equipment list:** Slat-less rubber coated contacts, single jumps, double jump, tunnels and 24" weave poles, electronic timing will be used.

Please keep your dogs on leash while not competing ~ No smoking is allowed; except within vehicles

NOTE: Dogs that require measuring will be measured Saturday and Sunday at 7:30 AM. Your confirmation will note if your dog needs to be measured. Dogs entering the standard division jump height classes 20" or less (with height less than or equal to 20"), that do not have a permanent ASCA, AKC or NADAC height card must be measured. Dogs entering 20"+ or 24" jump heights are exempt (includes Veteran Dogs, Junior Handler, ACE Std Division dogs entered in the 16"+, Sr. Dogs in the 12"+ jump height classes). - 1.2 Exhibitor/owner agrees to abide by the rules and regulations of ASCA and any other rules and regulations appearing in the premium for this event.
- 1.3 Exhibitor/owner certifies that the entered dog is not a hazard to persons, dogs, or property and that the entered dog's rabies vaccination is current in accordance with the requirement of the state in which the dog resides.
- 1.4 Exhibitor/owner acknowledges all hazards presented by the event and the event premises, including, but not limited to, the condition of the grounds, lighting, security measures or lack thereof, electrical appliances, fittings, show rings, parking areas and the presence of unfamiliar animals, and people; exhibitor/owner assumes the risk of any harm arising for these.
- 1.5 Exhibitor/owner releases ASCA (including all officers, directors employees, and members), WCASA, including all officers, directors, members and organizing committee/s, and the owners of Diamond Dogs K9 Events will defend them and hold them harmless from all present and future loss, injury, damage, claims, demands and liabilities involving the entered dog, the event or event premises. Without limiting the generality of the foregoing hold harmless provisions, exhibitor/owner hereby specifically assumes responsibility for and agrees to indemnify and save aforementioned parties harmless from any and all loss and expenses (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damages because of bodily injuries, including death, at any time in consequence of my (our) participation in this event, howsoever such injury, or death may be caused, and whether or not the same may have been caused or may have been alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents or any other persons.

Diamond Dogs K9 Events Center:

There will be port-a-potties available onsite. Overnight camping is available NO hookups. Dry Camping only. Please contact Sue Graham if you would like to stay overnight. Please keep grounds clean and pick up pet waste and NO SMOKING outside of vehicles.

DIRECTIONS to Diamond Dogs K-9 Events (formally Winning Edge Dog Sports):

From the South: Take the 91 Freeway East to the 71 (Chino Valley Freeway) North. Take 71 North to the Peyton / Riverside Drive exit. Turn right on Riverside Drive. Travel East 1/4th mile to Mc Crosky Road. (on the South / Right side of the street) Turn right on Mc Crosky Road. Drive to the end and through the gate the horse stable. If you pass RESERVOIR Ave., you've gone too far.

From the North: Take the 10 Freeway East / 60 Freeway East to the 71 Freeway South. Take 71 South to the Peyton Drive exit. Turn left and drive under the 71 Freeway. Peyton Drive turns into Riverside Drive heading East. Travel East 1/4th mile to Mc Crosky Road. (on the South / Right side of the street) Turn right on Mc Crosky Road. Drive to the end and through the gates to the horse stables. If you pass RESERVOIR Ave., you've gone too far.

ON THE 60 Frwy get off on Reservoir and head south to Riverside. Turn Right, and a quick Left onto Mc Crosky Road.

Note: To return to 71 Frwy North, go west on Riverside. To 71 Frwy South, go west on Riverside to Peyton. Take Peyton South to Chino Ave. onramp.

ASCA® Service Membership And QTracking Number Application

In order to have ASCA® trial points tracked and to receive ASCA® titling certificates, each non-ASCA® registered dog will be required to have an ASCA® QTracking Number.
