ASCA agility trial in Vantaa, Finland, 5th—6th of May, 2018

Judge: Allard Wagenaar, Belgium

Trial will be held under the current rules and regulations of ASCA.

Classes offered:

Saturday 5th May 2 Gamblers, 2 Regular, 2 Jumpers

Sunday 6th May 2 Jumpers, 2 Gamblers, 2 Regular

Location: Pitkäsuontie 8, 01230 Vantaa, Finland

The trial will take place indoors, on an artificial turf field,
30 x 30 meters in size.

Entries made and paid by end of the April 20th, 2018

10 € per run,

1-day package: all runs for one dog 54€,

2-day package: all runs for one dog 96€.

Entries made and paid between April 21st to May 2nd, 2018

13 € per run, no discounts.

Day-of-trial entries 15 € each.

No entries during May 3rd – May 4th 2018.

Max. 350 runs per trial day.

Note: In accordance with the Finnish law, docked or cropped dogs are not allowed to enter. If your dog has a natural bobtail, be prepared to prove it.

Ribbons will be awarded for the first four places in each event for each height division qualifying and non-qualifying scores count; Australian Shepherds and Other Breeds not separated. Green ribbons will be awarded for all qualifying scores. Rosettes will be awarded for titles completed at trial.

Agility obstacles will include: Dog Walk (rubber chip contacts, slats), A-Frame (rubber chip contacts, slats), Teeter-Totter (rubber chip contacts slat-less), Winged Jumps, Double Bar Jump, Tire Jump, Open Tunnels and Weave Poles (60 spacing)

This trial is open to all breeds and mixes. If your dog is an ASCA registered Australian Shepherd, fill in your dog's registration number where designated on the entry form. If your dog is not an ASCA registered Australian Shepherd or other breed and you would like to earn ASCA titles, you will need to obtain an ASCA QT number for your dog. The ASCA business office will track qualifying scores earned only by ASCA registered dogs. Once you have an ASCA QT number, use it as your dog's "ASCA Registration Number" on all entry forms.

No entry shall be accepted from a dog or handler disqualified from the ASCA agility program; a dog or handler disqualified from all ASCA programs; or a person not in good standing with ASCA.

AGREEMENT

The person who signs this agreement represents that he/she is authorized to enter into this agreement on behalf of both exhibitor and the owner of entered dog. In consideration of acceptance of this entry:

1.1 As used here, "ASCA®" means the Australian Shepherd Club of America®, its affiliate clubs and each of their members, officers, directors, employees, show chairs, show committees, and agents.

1.2 Exhibitor/owner agrees to abide by the rules and regulations of ASCA® and any other rules and regulations appearing in the premium for this event.

1.3 Exhibitor/owner certifies that the entered dog is not a hazard to persons, dogs, or property and that the entered dog's rabies vaccination is current in accordance with the requirement of the state in which the dog resides.

1.4 Exhibitor/owner acknowledges all hazards presented by the event and the event premises, including, but not limited to: the condition of the floors, stairways, halls, lighting, security measures (or lack thereof), electrical appliances, fittings, show rings, parking areas, and the presence of unfamiliar animals and people. Exhibitor and owner assume the risk of any harm arising from these.

1.5 Exhibitor/owner releases ASCA®, the ASCA® affiliate/licensee club FINASC (including its officers, directors, members, and event organizing committee), and site owner(s) Ojangan Koiraurheilukeskus Oy harmless from all present and future loss, injury, damage, claims, demands and liabilities involving the entered dog, the event, or event premises. Without limiting the generality of the foregoing hold harmless provisions, exhibitor/owner hereby specifically assume sole responsibility for, and agree to indemnify and save aforementioned parties harmless from, any and all loss and expenses (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damages because of bodily injuries, including death, at any time in consequence of my (our) participation in this event; howsoever such injury, or death, may be caused, and whether or not the same may have been caused, or may have been alleged to have been caused, by negligence of the aforementioned parties or any of their employees or agents, or any other persons.
