RALLY Trial #2: Registration 7:30-8:15 am / Start Time trial #2- 20 minutes after completion of Trial #1

RALLY ORDER: RM, RE, RA, RN (c,b,a each class)

2 Obedience Trials

JUDGE- LINDA SCALON/ CO: BN, N- U

OBEDIENCE Trial # 1: Registration 1:00-1:45 pm/ Start time 2:00 pm

OBEDIENCE Trial # 2: Registration 1:00-1:45 pm/ Start time- 20 minutes after completion of Obed Trial #1

OBEDIENCE ORDER: Sit & Down Groups, Utility, Open, Novice, Beg. Novice

The trial ring will be indoor on mats, 40' x 50' in size.

Classes will run in the orders listed above. Entries are limited to 25 per trial.

EXHIBITORS: List your dog's jump height. Use only the most current obedience and rally entry forms, both available at

or email the entry clerk or trial secretary for an entry blank. Day-of Registration will be accepted upon availability only.

All dogs over 6 months of age must have an ASCA registration number on the entry form. All non-ASCA registered dogs require an ASCA tracking number. Forms are available on the web site at

**** ENTRY FORMS – Remember to mark on form which open class you are entering in obedience: CDX or ODX,**

Indicate in rally what level: c, b or a, Indicate in obedience what level: b or a

ENTRY FEES:

\$15* Per dog for each regular or non-regular obedience class entered. Strip ribbons will be given for placements. Per Trial as applicable and as qualified, a ribbon will be given for: High in Trial Overall, High Combined

\$15* Per dog for each regular rally class entered. Strip ribbons will be given for placements. Per Trial as applicable and as qualified, a ribbon will be given for: High in Trial Overall, High Combined

DISCOUNTS:

\$50 If entering all Obedience trials and rally trials/SAME DOG.

\$25 If entering both masters and excellent rally in both rally trials/SAME DOG.

\$25 If entering both open and utility in both obedience trials/SAME DOG.
