### DETAILS

**Conformation:** All dogs 6 months of age or older showing must have an ASCA registration number and handlers must be prepared to show a copy of such. Only Australian Shepherds may enter puppy, Altered or Adult Classes. Jr's going for ASCA Merits or Finals must show an ASCA Reg. Aussie.

\*\*\*\*\*

**Rally classes are open to ALL Dogs!**

**NOTE:** Non-ASCA registered dogs MUST have an ASCA Tracking Number to compete. A Returned Check fee of \$35.00 will be charged if check is not valid at time of deposit.

**Attention Exhibitors:** Entries must be on an official ASCA entry form and signed on the reverse. Copies accepted only if they are completed with the agreement on the reverse side and signed.

A complete Rulebook for Each Venue can be found and downloaded at [asca.org](http://asca.org) under programs. Entries for each venue may be found at [asca.org](http://asca.org) under forms.

These shows will be judged and run under the show rules of The Australian Shepherd Club of America. No refunds will be given for dogs absent, disqualified, excused or barred from exhibiting by the show committee. Refunds will be given up to the close of the pre-entry deadline. Substitutions allowed with dogs that you own or co-own. No entry which specifies any condition as to its acceptance will be accepted. The show giving club, show chairman, their agents, officers, committee, and owners of property, assume no responsibility for loss, damages or injury sustained by exhibitors, handlers, or to any of their dogs or personal property and further assume no responsibility for injury to children. No entry shall be accepted for a dog or handler disqualified from the ASCA Conformation program; a dog or handler disqualified from any ASCA program; or a person not in good standing with ASCA.

ASC of Southern Florida reserves the right to ban anyone not in good standing with ASCA from either show site. Some of these shows are held on Private Property. Please have dogs free of Fleas and Ticks. Anyone having any dogs with or exposed to any communicable diseases within 30 days of this Trial are NOT allowed to attend per ASCA Rules. PLEASE KEEP the Place CLEAN.

Pooper scoopers and trashcan (for poop only) will be provided.

Any Bitch in season must stay out of the buildings until Rally is completed.
