Indoor, climate controlled facility, fully matted rings.**

**Directions to the show:**

From Loop 820, take Jacksboro Hwy (Hwy 199) west. Take Hwy 730 north for 6.8 miles. Make a right turn on Briar Road. Training building will be about a block up on the left.

**Trial Schedule for all days:****Obedience**

7:30a.m. to 7:45a.m. – Registration for day of trial entries if available, move-ups & check-in for all obedience exhibitors. Judging begins at 8:00am. Classes will run in the following order: Utility B, Utility A, Open ODX B, Open ODX A, Open CDX B, Open CDX A, Novice B, Novice A, Beginner Novice B, Beginner Novice A, Awards for Regular Classes followed by non-regular Sub-Novice class.

**Rally**

11:00a.m. to 11:15a.m. – Registration for day of trial entries if available, move-ups & check-in for all rally exhibitors. Judging begins 30 minutes after conclusion of the obedience trial. Classes will run from Masters C through Novice A.

The show site will open each day at 7:00a.m. and close following judging each day. No dogs may be left at the show site overnight.

**Fees:**

Fee structure for obedience and rally are separate. When calculating discounts for 2<sup>nd</sup> entries, the 2<sup>nd</sup> entry must be in the same event as the 1<sup>st</sup> entry.

**Obedience:**

Pre-Entry Price: \$15.00 for first regular class each dog, \$10.00 second regular class same dog/same day/same obedience trial. Junior Entry Price: \$10.00 each class entered. \$10 each non-regular class entered.

Day of Trial Price (if available): \$20 for each class entered. Junior Entry Price: \$15.00 each class entered. \$15 each non-regular class entered.

**Rally:**

Pre-Entry Price: \$15.00 for first regular class each dog, \$10.00 second regular class same dog/same day/same rally trial. Junior Entry Price: \$10.00 each class entered. \$5 per dog entered in Team.

Day of Trial Price (if available): \$20 for first class each dog, \$15.00 for second class same dog/same day. Junior Entry Price: \$15.00 each class entered. \$15 each non-regular class entered. \$5 per dog entered in Team.

**Awards:**

For obedience and rally, qualifying scores will receive a green ribbon; strip ribbons will be awarded for placements in each class. Rosettes will be awarded for High Scoring Australian Shepherd, High Scoring Other Breed, High in Trial Overall, High Combined, High in Trial Junior Handler in Rally and High Scoring Junior Handler in Obedience. In Rally, Qualifying scores of 195 and higher will receive strip ribbons indicating an "X" qualifying score. New Title ribbons will be available for those finishing an Obedience or Rally title.

If you are close to achieving your RTCH or OTCH please let the trial secretary know when you send in your entry form.

**Special Notices for Exhibitors:**

All Entries must be on official ASCA entry forms only. No other forms can be accepted. All entries must be signed. Entry forms can be downloaded at: <http://www.asca.org/Forms>. Entry forms for obedience and rally are different. If entering both obedience and rally, you will need two different forms.

Exhibitors, through submission of entry, acknowledge that they are knowledgeable of ASCA rules and regulations. No entry shall be accepted which specifies any conditions as to its acceptance.

All entries must be accompanied by a check or money order for the appropriate amount or will not be considered a valid entry and not be accepted for entry. Entry forms will be available at the check in table for Day of Trial Entries, as well as tracking number forms if needed.

No entry fees will be refunded. Make checks payable to TCASC. Returned checks do not constitute a valid entry and will be subject to a \$35 charge, and also reported to ASCA if restitution is not made in a very timely manner.

All dogs must have an ASCA registration number or an ASCA tracking number to compete with the exception of those who submit their application for a tracking number at the trial desk. No entry will be accepted without a tracking number, registration number or a valid application with a check made payable to ASCA for a tracking number. Dogs must be entered in classes they are eligible to compete (i.e. if you enter Open, you must have completed your ASCA CD with the dog you are entering).

The State of Texas requires a current rabies vaccination. All dogs over 12 weeks of age must have a current rabies certificate. A tag does not show proof of vaccination. Thank you for your cooperation.

NO dogs Under 6 months of age will be permitted at this trial.

Any handler, owner, or spectator using excessive abuse towards a dog or exhibiting poor sportsmanship will be asked to leave the Trial site for the duration of the Trial.

No entry will be accepted by persons or dogs not in good standing with ASCA.

Grooming, crating, food and dog treats must be kept at least 10 feet from the ring.

TCASC, their Boards of Directors, ASCA, its Board of Directors, and the property owner assume NO RESPONSIBILITY for any loss, damage, or injury sustained by exhibitors, handlers, or to any of their dogs, personal property, and/or children.
