Rally Trial will start with Masters B/A/C, Excellent B/A/C, Advanced B/A/C, Novice B/A/C

These trials will be held under the current rules and regulations of the Australian Shepherd Club of America (ASCA). No entry will be accepted from a dog or handler disqualified from the ASCA program, a dog or handler disqualified from all ASCA programs; or a person not in good standing with ASCA. High In Trial, High Combined & High Scoring Junior. High Scoring Australian Shepherd will be awarded if HIT is not an Australian Shepherd. All qualifying scores 170 and higher will receive a qualifying ribbon.

Rally Awards

High In Trial, High Combined & High Scoring Junior. High Scoring Australian Shepherd will be awarded if HIT is not an Australian Shepherd. Qualifying Ribbons will be handed out to each qualifier in Rally with scores of 170 through 194. X Qualifying Ribbons will be handed out to each qualifying score 195 and higher.

349 Route 31 South (in between and behind Dunkin' Donuts and Verizon – same shared driveway and all of the way BEHIND the big brick building in the back – the business in front is called Kickcharge – keep going)

GPS IS VERY SPOTTY IN THIS AREA. USING IT MAY GET YOU LOST – OR ROUTED THE LONG WAY AROUND. You MUST put the zip code in, because there are 3 Washington's in NJ and you will invariably be sent to the wrong town.

TO FIND THE POSITIVE DOGS TRAINING LOCATION THE DIRECTIONS BELOW WILL WORK FOR YOU.

From the east: Route 80 west to exit 26 (Budd Lake/Hackettstown). From the end of the ramp, go 7.5 miles on 46 west. At light, make a left onto 182S. Go 9/10 of a mile and at 3rd light, make right onto 57 west. Go 10 miles on 57 until you get to the corner of 31 and 57 (major intersection). Make a left onto 31 south and go exactly 1.8 miles. Make a right into the shared driveway of Dunkin' Donuts and Verizon and drive all the way to the back of the big brick building.

From the south: route 31 north. Depending on how far south you are... If you're coming off of route 78 onto 31 North, from the light at W. Main St, go 6.8 miles and make a left into the shared driveway of Dunkin' Donuts and Verizon and drive all the way to the back of the big brick building. (just past the Ford Dealer on left, after the big stand of trees). If you go past the Shop-rite (on your right), you went about 3/10 of a mile too far – turn around)

From Easton/Phillipsburg area: (from the corner of 519 and 57), turn onto 57 East. Go 9.4 miles. At corner of 57 and 31, make a right onto 31 south and go exactly 1.8 miles. Make a right into the shared driveway of Dunkin' Donuts and Verizon and drive all the way to the back of the big brick building.

From 22: – go away from Easton and where 22 meets 57, make left onto 57 East and go 9.4 miles. At corner of 57 and 31, Make a right onto 31 south and go exactly 1.8 miles. Make a right into the shared driveway of Dunkin' Donuts and Verizon and drive all the way to the back of the big brick building.
