\* **Junior Handling** - Any dog may be entered for competition in an ASCA-sanctioned Junior Handling class held at a conformation show. **This is an all-breed competition.** The intent of the program is that any youth may compete in the ASCA Junior Handling Program with any breed of dog, regardless of whom the dog belongs to. These dogs may be ASCA registered to include intact, altered or LEP, or registered in another registry, or other pure bred dogs or mixed breeds.

### **AWARDS**

First through Fourth place ribbons for each class offered.

Rosettes and/ or ribbons will be offered for (both Intact and Altered): Best of Breed, Best of Opposite Sex, Best of Winners, Winners Dog, Winners Bitch, Reserve Winners Dog, Reserve Winners Bitch, Best of Breed Puppy, Best Opposite Puppy, Best Junior Handler, Reserve Junior Handler, and participation ribbons for Non-Regular Junior Showmanship

*No Entry shall be accepted from a dog or handler disqualified from the ASCA Conformation program; a dog or handler disqualified from all ASCA programs; or a person NOT in good standing with ASCA.*

The show will be held outdoors on grass/dirt.

Please clean up after your dog(s) on the entire show grounds!
