Awards: Rally: Qualifying ribbons, X Qualifying ribbons for scores 195 or higher, placement ribbons 1st thru 4th places. High in Trial, High Combined, High Scoring Aussie, High Scoring Other Breed and High In Trial Junior.

All entries must be on current ASCA entry form. Non ASCA registered Rally dogs must have a tracking number. All conformation dogs over 6 months must have a permanent ASCA registration number. No entry shall be accepted from a dog or handler disqualified from or not in good standing with ASCA. ASCA rules and regulations will be followed. Poor sportsmanship will not be tolerated and those involved will be asked to leave without refund of entry fees)
