NOTICE TO EXHIBITORS

- This trial will be held according to ASCA regulations. Exhibitors, through submission of their entry, acknowledge that they are knowledgeable of ASCA rules and regulations, and agree to abide by all rules in effect at the time of this trial.
- ASCA, PEN-NY ASC and Paws for Thought will not be responsible for the loss or damage to any dog exhibited, or for the possessions of any exhibitor whether the result was by accident or any other cause. It is distinctly understood that every dog at this event is in the care and custody and control of his owner or handler during the entire time the dog is on the show premises.
- All dogs must be on a leash when not competing in the ring or at the practice jump/warm up area.
- Any exhibitor whose dogs and/or children create any unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Show Committee be asked to leave the show site. In such a case, no refunds will be made and the ASCA office will be informed of the problem.
- No entry will be accepted for a dog or handler disqualified from the ASCA Agility program or from all ASCA programs or any individuals who are not in good standing with ASCA.
- Please have your dog's rabies certificate available.
- In order to have ASCA qualifying legs tracked and to receive ASCA titling certificates, each non-ASCA registered dog will be required to have an ASCA QTracking Number. This is a one-time fee of \$10/dog. At the time of applying for the QTracking number, the individual owner must also be an ASCA member (minimum membership type of Service). ASCA membership does not need to be maintained in subsequent years. It will be the responsibility of the owner to identify to ASCA the shows and legs earned when applying for a QTracking Number after ASCA qualifying legs have already been earned. - Please include an e-mail address on entry forms to receive confirmation of pre-entries.
- All fees MUST be submitted in US Funds (Canadian Exhibitors please use International Postal Money Orders).
- Returned checks do not constitute a valid entry fee. Returned checks will incur a \$15 service charge.
- All poop must be picked up, bagged, and disposed of properly by the dog's handler. The Event Committee retains the right to excuse any competitor who fails to pick up after their dogs, either at the trial site or the motel.

REFUNDS

There will be no refund for entries withdrawn after the closing date, except for a dog's injury and/or illness or for bitches that come into season after the closing date. These entries will be eligible for a refund of the amount of the total entry fee less \$15. A signed letter from your veterinarian must be included with your written request. Requests must be received by the trial secretary prior to the start of the trial. There shall be no refunds for entries withdrawn in the event a dog and/or handler are dismissed from competition.

IMPORTANT INFORMATION ON ENTRIES:

- Entries postmarked before the opening date of Monday June 11, 2018 WILL NOT BE ACCEPTED
- Pre-entries must be received by Monday July 23, 2018
- Entries will be accepted by order of postmark.
- Do not mail your entries by any method that requires a signature.
- Entries cannot be accepted or canceled after the closing date.
- Entries must be submitted on the forms or copies of the forms supplied in this premium.
- Please double check your entry to ensure it is filled out completely and that you have signed the release form.

EQUIPMENT:

Slatless teeter, rubberized slatted A-frame and dog walk will be used. Jumps, including double, tunnels, displaceable tire, may be used at the judge's discretion. The A-frame shall be set at 5'6". Weave poles are 24" spacing.

Electronic timing will be used at this event.

MOVE-UPS

After submitting your entry, the last day that we will be accepting move-ups for the trial will be July 25, 2018. We will accept move-ups in writing only (mail or e-mail). No changes will be accepted after this date. Day to Day move-ups will be allowed during trial in person within 30 minutes of last run on Saturday.

DIRECTIONS

From Rochester Area: Take NYS Thruway (I 90) East to Exit 40. Right off exit onto Rt. 34. Follow Rt. 34 signs (thru Auburn) to Rt. 34B. Make a left at the light and proceed on Rt. 34B for approximately 6 miles and make a left onto Sharpsteen Road. Go to the end of the road and make a right on Hwy. 153-Pleasant Valley Rd. Take the first left onto Smith Rd. Show site will be on the left.

From Ithaca via Rt. 34B: Left onto Sharpsteen Rd., right onto Hwy.153-Pleasant Valley Rd. Take first left onto Smith Rd. Show site is on the left.

From Syracuse via I 81 South: Take Exit 12 (US 11/NY 41/NY 281) toward Homer/Cortland. Merge onto Main Street Connector. Left onto SR 281/NY281 about 2.2 miles. Right onto SR 222/NY 222 and follow about 9.2 miles. Left onto Main Street/NY 38 then first right onto Spring St./County Hwy. 100. Stay straight to go onto Spring St Ext./County Hwy 190 . Take first left onto Smith Rd./ County Hwy 178. Show site is on the right.

From Binghamton via I 81 North: Take Exit 11 for NY 13 toward Cortland. Left onto NY 13/Clinton Ave. Right onto Clinton Ave./Rt. 13. Stay straight onto Groton Avenue/NY 222. Follow NY 222 for approximately 10.4 miles. Left onto Main St./Rt. 38 then take first right onto Spring St./County Hwy 100. Stay straight to go onto Spring St .Ext./County Hwy 190. Take first left onto Smith Road/County Hwy 178. Show site is on the right.

REGISTRATION / MEASURING:

- Saturday and Sunday between 7:30 AM and 8:00 AM
- Copies of either ASCA, NADAC or AKC height cards may either be mailed in or presented at registration for dogs entering the Small and Medium dog Classes (dog's wither height 18" and under) as well as dogs jumping in the 20" class. Otherwise they will need to be measured at registration. 20+ and 24 inch classes do not need to be measured.

- Jump Height Metric Conversions: 4" (10cm), 8" (20cm), 12" (30cm), 16" (40cm), 20" (50cm), 24" (60cm)

- A dog may be entered in a class at a jump height higher than they are eligible provided the dog is not entered in the Veteran Dog SDivision classes.

- Any exhibitor whose dog measures over 20" may choose to enter the 20+ class or the optional 24" class. 20+ and 24 will be scored and placed together as one class.

- Refer to the current ASCA rulebook for the current Breed Jump Height Exemption List.

- The Veteran Dog Division (Championship program) is for dogs age 7 and older.

Potty Accident Fee:

Effective March 1, 2018, Paws for Thought Farm (PFTF) will be implementing a Potty Fee for any and all Potty Accidents (poops or pees) on the turf. A \$5 fee will be paid to Paws For Thought Farm for each occurrence.

AGREEMENT
