



10 Years Lowlands ASC Jubilee Agility Trial



All breeds and crossbreeds are welcome

Date: 21&22&23 September 2018

Judge: Allard Wagenaar

Location: Footballfield kiefhoek, Kiefhoekstraat 213, 3940 Eksel, Belgium

The trial will be held outdoors on grass, two fields

Entries open 25 July and close 8 September 2018; late entry are possible if runs are still available

Classes offered in the Championship Program: Regular, Veteran Dog Division, Junior Handler Divisions and ACE Program: Standard and Senior dog Divisions

Friday September 21th: 2 rounds of Regular

Saturday September 22th: 2 rounds of Jumpers, 2 rounds of Regular and 2 rounds of Gamblers

Sunday September 23th: 2 rounds of Jumpers, 2 rounds of Regular and 2 rounds of Gamblers

Entries limited to 100 Runs Friday & Entries limited to 400 runs Saturday/Sunday

This agility trial will be held under the current rules and regulations of ASCA. No entry shall be accepted from a dog or handler disqualified from the ASCA agility program, a dog or handler disqualified from all ASCA programs; or a person not in good standing with ASCA. An ASCA registration number is not required for entry, however, if you would like to have qualifying scores recorded and receive titling certificates, an ASCA registration or QT number is required. Friday: Measuring and late entries (if still available): 16:00-16.15 pm. Briefing and walking through from 16:15-16:25 pm. First dog on the line at: 16.30 pm

Saturday/Sunday: Measuring and late entries (if still available): 08.00-08.30 am. Briefing and walking through from 08.30-08.55 am.

First dog on the line at: 09.00am

Entry fees:

Pre-entries 5 euro/run

Package for 1day/dog 6 runs 30€

Package for 2 days/dog 12runs 55€

Package for 3 days/dog 14 runs 65€

Late entries and entries on the trial day 10 euro/run

Move ups:

Day to day move ups are accepted until 30 minutes after prize ceremony.

Prizes: Ribbons for 1st-4th place and qualifying scores. High in Trial awards for the Championship Program: HIT Overall Standard Division, HIT Overall Veteran Dog Division, HIT Overall Junior Handler Division. Each Elite 10 pt Q will be worth 7 points, each Open 10pt Q will be worth 6 points, each Novice 10pt Q will be worth 5 points. Faulted (5 pt) Q's will be worth half the point value. Tie breaker will be fastest combined YPS in the Regular classes.

Obstacles: Weaves (24inches), A-frame (~1.6m), dog walk, teeter-totter, open tunnels, winged jumps. Contacts are rubber with slats.

Bitches in heat /docked dog: Bitches in heat will not be allowed at the trial. Docked dogs born on or after Jan 1st, 2006 are not allowed to compete in Belgium.

Cancellation policy: By sending in the entry form you commit yourself to the payment of the entry fees.

Cancellation with refund only possible before closing of the pre-entry dead-line

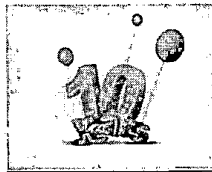

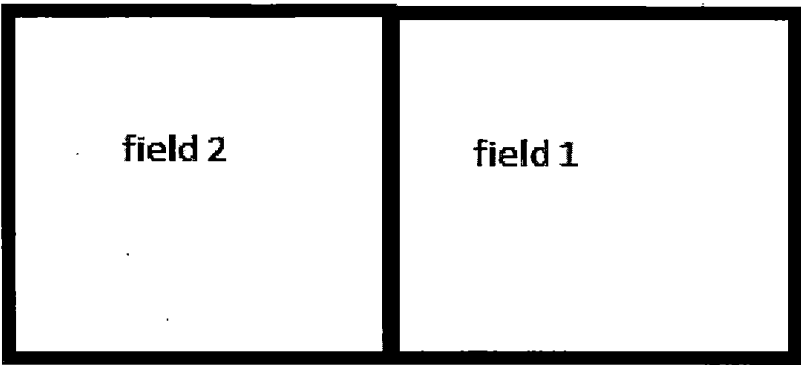

- 1.2 Exhibitor/owner agrees to abide by the rules and regulations of ASCA® and any other rules and regulations appearing in the premium for this event.
- 1.3 Exhibitor/owner certifies that the entered dog is not a hazard to persons, dogs, or property and that the entered dog's rabies vaccination is current in accordance with the requirement of the state in which the dog resides.
- 1.4 Exhibitor/owner acknowledges all hazards presented by the event and the event premises, including, but not limited to: the condition of the floors, stairways, halls, lighting, security measures (or lack thereof), electrical appliances, fittings, show rings, parking areas, and the presence of unfamiliar animals and people. Exhibitor and owner assume the risk of any harm arising from these.
- 1.5 Exhibitor/owner releases ASCA®, the ASCA® affiliate/licensee club Lowlands ASC (including its officers, directors, members, and event organizing committee), and site owner(s) of Footballfield kiefhoeek, harmless from all present and future loss, injury, damage, claims, demands and liabilities involving the entered dog, the event, or event premises.
