**ENTRIES AND CHANGES** – Entries submitted prior to the Opening Date will *not* be accepted. Requests for changes or move-ups to your entry must be received in writing or email to the Trial Secretary by June 5, 2019. Day to day move-ups will be accepted.

**MEASURING** - Dogs with a wither height of 20" or less will need show proof of measurement or be measured at the trial, unless they are jumping in the highest jump height in that category/division.

#### TRIAL SITE INFORMATION

The trial will be one ring, 100' x 100' outdoor on sand/dirt. Equipment may include the following: Dog walk (12' rubber slatless) A-frame (rubber slatless, height 5'3"), teeter-totter (rubber), open tunnel, weave poles (24" spacing), displaceable tire, jumps (single and double).

Toys will be allowed for training in the ring. See the ASCA Agility June 2019 rulebook for more information.

**AWARDS** – First through fourth place ribbons will be awarded for each jump height in all classes and levels. Qualifying ribbons will be awarded for each qualifying run. Rosette will be awarded for new titles. **High in Trial** - A large rosette and director chair will be given to the High in Trial Australian Shepherd and High in Trial Other Breed. ASCA registration or QT Tracking Number is required. Must enter at least 8 classes to be eligible. Pre-Novice and FEO do not count for High in Trial. Each 10 point Q is 1 point and a 5 point Q is 1/2 point. In the event of a tie, the following procedures shall be used for breaking the tie. First tie breaker: The dog with the most points in all rounds of the Regular classes. Second tie breaker: The dog with the highest number of total gamble points with a qualifying score. Third tie breaker: The dog with the most points in all rounds of the Jumpers classes.

If you may finish an ATCH or ACE during this trial, please inform the Trial Secretary before the trial.

**PRE-NOVICE** - The Pre-Novice class is a non-regular (non-titling) class open to any dog over the age of age of 12 months. Dogs under 18 months entered in the Pre-Novice class must jump at least 4" lower than their normal jump height. The teeter-totter and weave poles will not be used. (Shown as the P-Nov level on the entry form.)

**FEO (FOR EXHIBITION ONLY)** - The minimum age for dogs entered in FEO is 15 months of age. Any dog younger than 18 months of age must jump at a lower height than their regular jump height. No points towards titles will be earned in this division.

## NOTICE TO EXHIBITORS

Exhibitors, through submission of entry, acknowledge that they are knowledgeable of ASCA® rules and regulations, and agree to abide by all rules in effect at the time of this trial.

This trial is sanctioned by the Australian Shepherd Club of America (ASCA®) with the Prescott Australian Shepherd Club (PASC) as the sponsor club. Exhibitors through submission of their entry acknowledge that they are knowledgeable of ASCA® rules and regulations, including the following rules regarding entry.

- All healthy, trained dogs over eighteen (18) months of age are eligible to compete for titles in ASCA® agility trials.
- The handlers should always conduct themselves in a sportsmanlike fashion.
- Bitches in heat, lame or blind dogs are ineligible for entry.
- Any dog which demonstrates aggression towards any person or any dog, whether inside the ring or outside the ring, must be excused from the agility trial.
- I (we) further agree that when my dog(s) are left unattended, they will be secured in a crate or x-pen. Owners/handlers whose dogs are tethered or improperly secured will not be allowed on the show grounds.
- No collars, leads, food, toys, clickers, or other aids or devices shall be permitted on the course or within ten feet of the ring entrance at any time. The only exception to this is leading your dog to the start on lead. All dogs should be on leash when not competing or in the warmup area.
- Safety shall always be the foremost consideration in actions and conduct by handlers at all times.
- No entry shall be accepted from a dog or handler disqualified from the ASCA® agility program; a dog or handler disqualified from all ASCA® programs; or a member not in good standing with ASCA®.
- The sponsoring club will not be responsible for the loss or damage to any dog exhibited, or for the possessions of any exhibitor whether the result be accident or other cause. It is distinctly understood that every dog at this event is in the care and control of his owner or handler during the entire time the dog is on the show premises.
- Participation is a privilege afforded by the Host club and may be extended or withdrawn by the Host club's trial committee on suitable cause only. Refusal of such entries will be reported to ASCA®.
- There will be no refunds in the event that a dog and or handler are dismissed from competition, regardless of the reason.
- A 100% refund will be given for any request received prior to the closing date. Requests for a refund of entry fees after the closing date, up to the day before the trial, will be honored less any expenses incurred by the Prescott Australian Shepherd Club, and will be issued for the following reasons: bitches in heat, dogs injured or ill (with verification from vet on request) or family emergency. Checks not honored by the bank do not constitute a valid entry fee. There will be a \$30.00 service charge for bank returned checks.
- The Junior Handler Division is open to any dog that is being handled by a junior handler who is 17 years of age or younger. Dogs entered in the Junior Handlers Division classes may jump 4" lower than their regular jump height.
- The Championship Veteran Dog Division is open to any dog age seven (7) or older. Dogs entered in the Championship Veteran Dog Division classes will jump 4" lower than their Championship Standard jump height.  
The ACE Senior Dog Division is open to any dog age ten (10) or older. Dogs entered in the ACE Senior Dog Division classes will jump 4" lower than their ACE Standard jump height.
- Current Jump Height Table, Breed Exemption List, description of classes, levels, and divisions are included in the current ASCA® Agility Rules and Regulations Handbook.

### ASCA® ENTRY INFORMATION

- All ASCA® agility trials are open to purebred and mixed breed dogs.
- Dogs do not have to have an ASCA® registration or QT number to participate in an ASCA® agility trial.
- If your dog is an ASCA® registered Australian Shepherd, fill in your dog's ASCA® registration number where designated on the entry form.
- If your dog is not an ASCA® registered Australian Shepherd and you would like to earn ASCA® titles, you need to obtain an ASCA® QT number for your dog. Any dog is eligible to get an ASCA® QT number (not just Australian Shepherds). Once you have an ASCA® QT number, use it as your dog's ASCA® registration number. The ASCA® Service Membership and QT Number Application can be obtained at the ASCA® website ([www.asca.org](http://www.asca.org)) under "General Forms" and will also be available at the trial.
