MPS **Must** Run in all 3 classes of stock both days in Started.

### **Handlers Meeting for All Levels & Stock - 7:00am**

Order of judging: as soon as Handlers meeting is over, to begin with Cattle, then Ducks, then Sheep.

**No arenas to run concurrently.**

Run order to be drawn prior to trial. Bitches in Season will be allowed to run, will run in order drawn and must be crated at vehicle while not competing. No refunds without a Veterinarian excuse. You may substitute a dog you own or co-own in its place

**Entry Fees:** Ducks-\$45 per run, Sheep-\$50 per run, Cattle- \$55 per run

Day of Trial entries (if space allows): add \$5 per run

**Please Note this is separate entry from the Farm Dog Trial. Please send them separately!**

**Entries open June 10th and may not be postmarked before June 10th**

**Entries Close June 25th. After that all entries will be charged the "Day Of" Fees**

**Attention to All owners of dogs NOT registered with ASCA**

All non-registered ASCA dogs must have an ASCA Tracking number for any ASCA scores to be recorded and titles earned and owners must be at least a Service Member of ASCA. If you want your scores recorded for ASCA titles you must have a tracking number. There are fees associated with obtaining a tracking number that are over and above your entries fees. Tracking number forms and all information are available @ [www.asca.org](http://www.asca.org) and will be available at the trial.

Any check returned to our bank will invalidate all entries associated with that check. In addition, all exhibitors and/or owners for which a check has been returned will be reported to ASCA – NO EXCEPTIONS. There will be a \$30.00 collection fee added to the amount of each returned check. Any exhibitor/owner with a check returned must pay all future FRASC event fees by cash, money order, and/or cashier's check.

Refund of entries - Pre-entries will be refunded only upon written request received prior to close of pre entries. No other entry refunds will be granted; however, you may substitute any dog you own or co-own in its place

**General Information:**

- Smoking in vehicles only!!!!
- Parking in designated areas only.
- There is NO Shade so bring your own – All canopies must be staked down.
- All dogs must be **on leash** at all times except while competing, no exceptions!
- You must pick up after your dog. Also, do not allow dogs to urinate on the fences or rosebushes.
