If you wish to obtain ASCA titles, you MUST obtain an ASCA tracking number if the dog is not an ASCA registered Australian Shepherd. Entries must be complete and correct or will not be accepted.

Directions to Trial Location

From the North: turn right at the Y in Soldotna onto the Spur Hwy. Go through town and up the hill. You will see a open hay field on the right and a sign that says Sport Lake. go about 500' and turn left on Lancashire Road. There is a short section of pavement, road splits & becomes gravel. Take left hand option.

TRIAL INFORMATION

- *If entries exceed the number of runs, then the postmark date will be used and a waiting list will be maintained. Entries on the waiting list will be notified by phone if runs become available.*
- Advanced dogs will run first, Open second, Started third, followed by Juniors.
- Bitches in season will run last.
- Order of runs will be pre-drawn after the PreEntry Date has passed and prior to the trial.
- Day-of-show entries (IF available) will be added to the end of runs as they are accepted.
- This Stock Dog Trial is open to all herding breeds listed in the Appendix 1 of ASCA's Stock Dog Rules. (Available at www.asca.org)
- **IF YOUR DOG INJURES OR KILLS A DUCK THE COST IS \$35.00.**
- When you arrive for the trial, please keep your dog on leash when it is not actively working the livestock in the arena. All dogs must be kept away from the arena except during their run.
- A potty area will be available for your dog(s). Please use the designated area only.
- Bring what you need for the comfort of your dog(s) such as leash, water dish, crate, and shade material.
- The closest places to eat is Soldotna, you should bring whatever food and water you need for your comfort and your dogs.
- This is an outdoor trial, rain or shine. Trial grounds are grass and packed dirt.

9 A.M. Start Time, beginning with a Handler's Meeting

- Duck Arena: 90 X 60; take pen 8 x 8 minimum
- Entry fees will be refunded *only* when a dog has been certified by a licensed Veterinarian as unable to compete due to sickness or injury.
- Refunds will be given if the trial fills and there is a replacement. Dogs may be substituted if owned by the same person.
- Note: If the runs for the first trial do not fill, they will be added to the second trial. If the trial does not fill, the number of runs may be adjusted
